The Address of Welcome was provided by Firefighter Matt Donahue and the response offered by past president Frank Ceresini III.

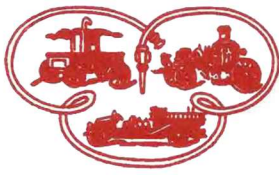
A roll call of officers was followed by the reading of the minutes from the previous meeting which were approved as read.

On a motion by Jay Rhoads and Frank Ceresini III to purchase a refrigerator, gloves, and hoods for the fire school. Motion carried

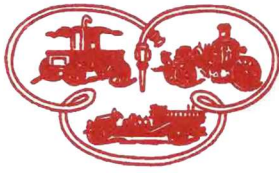
On a motion by Frank Ceresini III and Jason Weikel to purchase 6 polo shirts for honor guard use, not to exceed \$500.00. Motion carried.
