The Address of Welcome was provided by Assistant Chief Ken Martin, and the Response offered by Ronald Miller.

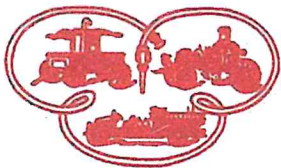
A roll call of officers and delegates was held followed by the reading of the minutes from the previous meeting which were approved as read.
